APPROVAL OF MINUTES

President Cooke questioned if there were any additions or corrections to the minutes of the May 11, 2023 Regular Meeting.

2022 AUDIT REVIEW LAUTERBACH & AMEN, LLP

Don Shaw of Lauterbach & Amen presented the 2022 Audit Report and Annual Comprehensive Financial Report. Don also shared that the District earned a Certificate of Achievement Award for the fiscal year ending in 2022. This award represents the highest form of financial reporting excellence. Don explained the audit report provided a clean, unmodified opinion. That is the highest level of opinion you can receive. Don ended by sharing some details of the report.

Commissioner O'Malley asked Don about the district making accelerated payments to the IMRF pension retirement system. Don explained it is a management decision to make accelerated payments. He noted the district is 94% funded. Commissioner Walz asked how that 94% compared to other districts. Don said it is well funded and 90-100% is considered well funded. Don explained market fluctuations are a considerable factor.

FINANCE COMMITTEE

Corporate Fund

- > \$1,326,562 in property tax was collected in April.
- > \$199,951 in Personal Property Replacement tax collected in April.
- ➤ All expense categories are at or under budget except unemployment insurance because of a timing in payment.
- > YTD of \$2,495,004 compared to a budget of \$2,019,864.

Recreation Fund

- > \$627,927 in property tax collected in April.
- > Fees & Admissions \$393,638 compared to a budget of \$353,280.
- > Program fees were \$650,744 compared to a budget of \$706,075.
- ➤ All expense categories at or under budget except program contractual.
- > YTD of \$746,667 compared to a budget of \$242,761.

Commissioner Walz asked Director Sholes to explain the \$500,000 difference in YTD. Director Sholes stated there are open full-time positions in the rec department. The majority of the variance is unspent capital dollars that have been budgeted from the recreation department.

Golf Fund

- > 3,296 rounds played in April.
- > Fees & Admissions \$200,140 compared to a budget of \$157,705.
- > All expense categories are at or under budget YTD.
- > YTD of (\$52,431) compared to a budget of (\$204,637).

COMMITTEE OF THE WHOLE

President Cooke shared topics discussed at tonight's Committee of the Whole meeting include:

- > The Community Wide Survey Questionnaire. Please respond to the survey. This is the time to provide input as this information helps develop our master planning and future vision.
- ➤ The Property Naming Rights Policy.
- The Fitness Center and feedback from members with equipment removal. The board has directed staff to bring back 5 pieces of equipment and provide better communication on upcoming and future projects.
- > Future Board Positions on the board.

ATHLETIC COMMITTEE

- ➤ House Softball and House Baseball Games are in full swing for both sports and the coaches are in the process of selecting their All Stars and Home Run Derby players for the June 16 Home Run Derby and the June 17 All Star games. Fall Softball and Fall Baseball registration is open now through the end of July.
- Travel Baseball Games are on going, and teams participated in local and out of town tournaments in the month of May. Teams are about halfway through their MSBL season and will have end of season MSBL Tournaments in late June and early July.
- ➤ Football and Cheer Football 7-on-7 Spring League concluded on Saturday, May 7. The league was very successful with 98 participants in Grades 3-8. Registration for Flag and Tackle Football along with Competition and Flag Cheer is currently open for the Fall 2023 season.
- Soccer Travel Soccer tryouts for the Fall 2023/Spring 2024 season were May 9 and 10 at Community Athletic Fields. Approximately 300 players participated in tryouts ranging from ages U7-U15. Team offers have been made and parents are in the process of paying their deposits. Recreational House Soccer going well and if scheduled to end on Saturday, June 10th.

GOLF COURSE COMMITTEE

Commissioner Carlson said golf is in really nice shape. A few upcoming events: June 3rd - Part of the Summer Music Series, Kerosene from 7-10 pm with no cover charge. June 17th - Part of the Summer Music Series, No Limit from 7-10 pm with no cover charge. July 8th - Dueling Pianos. July 22nd - Nicole Devine. Director Sholes also added Nicole Devine is playing this Saturday, the 27th, as well as the July date.

YOUTH COMMITTEE

Commissioner Carlson said they received 17 applicants and they are going through the blind selection process. They have a meeting on June 3rd to finalize winners. Commissioner Biedke recommends presenting the winners at the second meeting in June.

ADULT CENTER COMMITTEE

President Cooke had no report.
