

## MINUTES OF THE REGULAR PUBLIC MEETING

A Regular scheduled meeting of the Elk Grove Park District, Cook County, State of Illinois was held on January 9, 2020 in the Administration Building of said Park District. President Walz called the meeting to order at 7:16 p.m. and upon the roll being called, President Walz, being physically present at such time and place and the following Park Commissioners, also being physically present at said time and place, answered present:

#### **PUBLIC HEARING**

At 7:17 p.m., President Walz announced that the next agenda item for the Board of Park Commissioners was a public hearing (the "*Hearing*") to receive public comments on the proposal to sell not to exceed \$2,500,000 General Obligation Limited Tax Park Bonds (the "*Bonds*") for the building, maintaining, improving and protecting of the existing land and facilities of the District and for the payment of the expenses incident thereto, and explained that all persons desiring to be heard would have an opportunity to present written or oral testimony with respect thereto.

President Walz opened the discussion and explained the reasons for the proposed issuance of the Park Bonds were as follows: For the building, maintaining, improving and protecting of the existing land and facilities of the District and for the payment of the expenses incident thereto.

Whereupon the President asked for additional comments from the Park Commissioners. Additional comments were made by the following: None were made.

Written testimony concerning the proposed issuance of the Bonds was read into the record by the Secretary and is attached hereto as *Exhibit I*. None were made.

Whereupon the President asked for oral testimony or any public comments concerning the proposed issuance of the Bonds. Statements were made by the following: None were made.

The President then announced that all persons desiring to be heard had been given an opportunity to present oral and written testimony with respect to the proposed issuance of the Park Bonds.

Park Commissioner O'Malley moved and Park Commissioner Souder seconded the motion that the Hearing be finally adjourned.

After a full discussion thereof, the President directed that the roll be called for a vote upon the motion.

#### **APPROVAL OF MINUTES**

President Walz questioned if there were any additions or corrections to the minutes of the December 12, 2019 Committee of the Whole Meeting and the December 12, 2019 Regular Meeting.

There being none, the minutes were approved by a unanimous voice vote.

## **COMMENTS FROM AUDIENCE**

Resident Gary Buczkowski addressed the Board regarding his concerns over the cost of the new Fox Run clubhouse and maintenance facility and what the return on this investment would be. President Walz replied to him that the question has come up before. If we were to take away the golf course, does it take away from the community? President Walz believes it is an important piece of the community. He added that the original clubhouse was built in 1983 and is in disrepair. The maintenance facility is also in need of an upgrade as well due to the growing needs and equipment required to maintain the course.

President Walz stated the project actually began with rebuilding the maintenance facility but after reviewing options, it was determined that it would be more cost efficient in the end to rebuild both facilities at the same time. The design of the new clubhouse will allow room for golf simulators as well as other programming such as bags to generate revenue. Mr Buczkowski asked if Tom Klaas can come up with \$489 per day in programming. A figure he came up with based on the cost of the project. Commissioner Cooke stated the District has an obligation to maintain its facilities and reminded Mr. Buczkowski that the Board members are all taxpayers as well. Commissioner Cooke went on to explain that this project, as well as all projects, are planned over years not to have to go to referendum. Commissioner Cooke told Mr. Buczkowski that he would be happy to share the information from the public meeting that was held last night that he was not able to attend. President Walz thanked Mr. Buczkowski for coming and for sharing his concerns.

### **APPROVAL OF 2020 BUDGET**

Commissioner Souder moved to approve the 2020 Budget as presented at the December 12, 2019 Committee of the Whole Meeting.
