LEISURE SERVICES UPDATE

Director Tiffany Greene gave the following update:

- ➤ As of the end of January, the Sheila Ray Adult Center has 176 members.
- ➤ Private Lessons are continuing to grow with the new format at the Pavilion Aquatics Center allowing for more lessons. There were 38 private lessons for the month of January.
- Tumbling Times' first winter session has 128 participants, and for the first time they are going to be hosting a state tumbling meet on February 26.
- There are 24 teams in the Fall Bags League, which is back at Fox Run. There are two divisions with 16 competitive teams and 8 recreational teams.
- ➤ Most of the youth athletic teams are in winter training. Football will be participating in a 7 vs 7 League in the spring.
- ➤ Mary Poppins rehearsals are underway with a cast of 50. The show dates are March 17-19.
- ➤ Winter Dance recital took place on January 30, at Elk Grove High School, with over 600 people in attendance and over 1,000 people watching at home via livestream.
- ➤ There were 27 total rentals for the month of January.
- Family Nerf Night had 40 participants. A special thank you to Foam from Above for attending the event and passing out nerf blasters, darts and swag.
- > Upcoming events include:

 - February 16 Sheila Ray Center Open House from 11am-12:30pm at the Adult Center.
 - February 18 Parent's Night Out from 5:30-8:30pm at Pavilion Aquatics Center. This event is for kids ages 5-12.
 - March 3 Dancing with the Band from 7-9pm at Garden Terrace.
 - March 4 Under the Sea Dance from 6-8pm at the Pavilion.

PARKS AND PLANNING UPDATE

Director Mark Kosbab stated staff has been busy with regular maintenance duties. The Facility Team have been busy with regular building maintenance while the Grounds team have been pruning and maintaining the ice rinks. Both teams have been working hard on clearing snow and getting capital projects off the ground and preparing bids. Ice rinks are weather dependent so information regarding whether the ice rinks are open will be posted on our website. This week, staff started control burns at Olmsted Park. Next week they will do Morton Park in effort to restore the shore line.

BUSINESS SERVICES UPDATE

Director Brad Sholes gave the following update:

- > The Park District is still hiring. Check our website for a list of all open positions.
- > Our auditors were on site all week. They wrapped up today and will finalize the audit in the next couple of weeks.

MINUTES – FEBRUARY 10, 2022

The Golf Course had a great first month in January. We will continue to tweak operations and have introduced weekday lunch specials and nightly drink specials. The simulators are very popular so don't hesitate to reserve your time as they fill up quickly. Keep in mind if someone has reserved a time after you, you will be asked to step out and let them go in their timeslot. Fox Run is hosting a Super Bowl special. Reserve a table from 5-11pm for \$30 per person which includes buffet, three drinks, drawings for free golf and simulator time.

Commissioner O'Malley stated he has heard from multiple people who have applied for positions and not been given a call. Director Sholes responded that they are still in the process of hiring and the jobs are posted on multiple platforms but they should follow the instructions to apply through our website.

Commissioner O'Malley also stated that he is still waiting on the information he requested on 457b contributions. Director Sholes responded that he is working on putting that information together for him.

MARKETING AND COMMUNICATIONS UPDATE

Director Kelly Carbon shared the following information:

- > The Summer Camp Activity Guide will be available online next week. It will be mailed out to the residents soon after that.
- The Spring Brochure will be mailed to residents by the end of the month with registration beginning on March 2 for residents and March 7 for non-residents.
- > Pavilion Fitness will be distributing a heart healthy treat on Valentine's Day.
- There are two new digital display boards installed in the Fitness Center. These will provide information on happenings throughout the District.
- ➤ An advertising campaign has been running in the Daily Herald as well as on Social Media promoting Fox Run.
- > We have a new part time customer service team member that started this week.

EXECUTIVE DIRECTOR UPDATE

Executive Director Ben Curcio shared that Governor Pritzer announced on Wednesday the mask mandate will be removed on Monday, February 28. Cook County Public Health has stated that they will align themselves with the Governor lifting the mask and vaccine mandate as well.
