#### **APPROVAL OF MINUTES**

President Cooke questioned if there were any additions or corrections to the minutes of the August 11, 2022 Committee of the Whole and the August 11, 2022 Regular Meeting.

Director Sholes explained the District is required to certify compliance with the Credit Card Industry Data Security Services (PCI-DSS), and is now required to review and update the PCI-DSS Compliance Policy annually.

## **COMMITTEE OF THE WHOLE**

President Cooke stated that at tonight's meeting, there was discussion on fee increases for 2023. Staff will do additional follow up in some areas and bring the information back to the Board to approve before the October 17 deadline. There was also discussion on signage for Souder's Point and discussion on the District's contribution to the Village Concert Series.

### ATHLETICS COMMITTEE

Commissioner Biedke shared the following information:

- ➤ Fall Softball games begin Saturday, August 27 with 122 players signed up across three divisions.
- ➤ Another round of tryouts for 8U and 9U Travel Baseball on September 29.
- > Fall House Baseball has begun with 155 players from grades 1 through 8.
- > Football games begin on August 27 with four tackle teams and one flag team.
- ➤ Fall Soccer has 248 players registered. Games begin September 10. Travel Soccer games also begin on that day.
- > Basketball registration is currently open. Tentative registration deadline is October 1.
- Last week a President's Meeting was held with all athletic league presidents in attendance, including the incoming House Baseball President. All Presidents gave a report on the state of their program. Other topics discussed included fee recommendations, 2023 budgets, capital projects wish list, resident policy, Marketing support, staff support, fundraising, and then closed out the meeting with open discussion and questions. Commissioner Biedke commended the Athletic's staff for working so well with the Athletic programs. Director Greene added that the biggest topic discussed at the meeting was the non-resident fees and how the other programs were very supportive of Football waiving the non-resident fee and there wasn't an interest in any other program wanting to do that at this time except for Travel Soccer. Commissioner Biedke said the the Athletic programs will also work on a timeline with Marketing so information can be included in the seasonal brochures and possible a mailing to the community of all the Athletic programs and what they have to offer

#### **GOLF COURSE COMMITTEE**

Commissioner Carlson gave the following update:

- ➤ High School Golf is in season and both Elk Grove High School and Conant High School use Fox Run. They have been able to utilize the simulators during bad weather.
- > The Senior Simulator Leagues will begin taking sign ups soon.
- ➤ Club Championship is set for September 17-18
- ➤ Nine & Stein will be held on September 22
- ➤ A new Halloween Scramble will be on October 28
- > Turkey Shoot will be on November 12
- > Wednesday night Bags league starts up on September 28

President Cooke asked for information on pricing for the Senior Simulator League. Director Sholes replied they are still working on that.
