ATHLETICS COMMITTEE

Commissioner Biedke gave the following update:

- > Travel soccer participated in tournaments the past two weekends. The 11U team took first place in their tournament.
- > Recreation soccer's fall season is taking place now with 152 participants.
- ➤ Basketball registration currently has 72 participants signed up. The numbers are low due to the mask mandate.
- ➤ Football has four games left of the regular season. There are 70 tackle players and 26 flag players,
- > Cheer has 26 participants for competition cheer and 19 for sideline cheer.
- The fall season of softball will wrap up in October with 113 participants.

GOLF COURSE COMMITTEE

Commissioner Carlson gave the following update:

- ➤ The Club Championship was held on September 18 and 19. This year's champion is Mike Helms with two day scores of 78 and 74. This is Mike's third time winning the championship.
- > The 3 Club Tournament will take place on October 16.
- ➤ Cesar Betancourt was hired as the new Fox Run Kitchen Manager. His first day was September 17 and he is already busy working on staffing needs, equipment and supply lists, and putting together a menu.
- The trailer will be removed on October 15 so the parking lot work can be completed. There will be another temporary setup until we get occupancy of the new building.

YOUTH COMMITTEE

Commissioner Carlson said the Teen Bonfire is set for Saturday, October 2 from 7:00-9:00pm at Lions Park. This event is for kids ages 11-16. The concession stand will be open.
