Drew Fisher is the District's new Athletics Supervisor. Drew began his career as a part time employee of the Schaumburg Park District. In 2018, Drew became the Athletics Supervisor of the Itasca Park District before coming to the Elk Grove Park District in October 2021. Jason Pilecki, Athletics Manager, comes to the District with over 13 years experience in the Park District field. He was hired as the Athletic Assistant in April of this year before accepting the position of Athletics Manager on September 1.

## **LEISURE SERVICES UPDATE**

Director Tiffany Greene gave the following update:

- > The Sheila Ray Adult Center has 254 active memberships as of the end of October.
- The Sheila Ray Adult Center and Elk Grove High School partnered and hosted Senior Olympics on October 20.
- ➤ A new event, Murder Mystery Dinner, was held on October 8 with 22 registrants.
- > 30 Dogs participated in the annual Doggy Trick or Treat event this year.
- ➤ The H2OoOooo event took place on October 15 with 107 in attendance.
- To date, there are 430 enrolled in Youth Swimming/Diving Lessons for the fall/winter season.
- ➤ Aqua Wellness classes are underway with a total of 756 participants in October.
- ➤ Hot Shot Sports has seven classes running in session 2 with 73 total participants.

- ➤ Both Volleyball classes are running with 23 total participants.
- > Tumbling Times went from 123 participants in the Fall Session I to 138 in Fall Session II.
- ➤ Adult Bags completed 6 weeks of matches with 22 teams.
- ➤ Fall Youth Athletics have wrapped up for the season.
- > 9U Eagles tackle football won their first playoff game on October 30.
- Competition Cheer has 23 cheerleaders competing. The Junior Squad has already received their bid to state.
- ➤ Basketball currently has 268 players enrolled for the fall/winter season.
- The indoor skate park opened on Friday, October 1 for the season. There were 189 admissions for the month of October.
- Private Music lessons have 22 students and Art Club has 10 students. Students are preparing for the upcoming Art and Music Showcase on November 23.
- > Dance currently has 330 registrants for the 2021-22 Dance Season.
- There are 148 children registered for the 2021-22 Preschool year. There are eight registered participants in the ACES Club. Spots are still available for both Preschool and ACES.
- The Fitness Center ran a Zombie Walking Challenge from October 1-31 with 97 participants. There were also 82 personal training sessions for the month.
- The District welcomed Madison Pogue as the new Museum Coordinator. Her first day was October 18.
- ➤ Kids Club Before and After Care is running at all five elementary schools with daily utilization totaling 1,758 in October. There were 38 registrations for School Days Off.
- ➤ The District's annual Halloween Fest was held on October 22 with 478 people in attendance. This event took place at the Pavilion, Pirates' Cove and the Museum.
- Upcoming events include; Veterans of Elk Grove Commemoration on November 13, Veterans Luncheon at Hattendorf on November 17, Moana Jr performances on November 20 and 21, and the Art and Music Showcase on November 23.
- Upcoming Holiday events include Letters to Santa drop off between December 1-11, Reindeer Games on December 7 at the Pavilion, and Holiday Bazaar on December 9 and 10 at Hattendorf.

# PARKS & PLANNING UPDATE

Director Mark Kosbab gave the following update:

- Staff have been working on fall clean up and winterization of parks and facilities. The irrigation systems are being blown out and the winterizing of the neighborhood drinking fountains is complete.
- ➤ Holiday lights are being installed.
- The pour-in-place surface has been installed at Jaycee Park. Staff completed the playground mulch as well. The remaining playground features, shelter, and landscaping will be completed next week by our construction crew.
- The streambank stabilization project has been completed at Morton Park and Martam Construction has moved to the Olmsted side.
- Demolition work has begun on the Pirates' Cove playground. The wall has been removed as well as some planting to make room for more features.

### **BUSINESS SERVICES UPDATE**

Director Brad Sholes gave the following update:

- The District is still hiring in a number of different areas including positions at the new Fox Run Clubhouse. Information of all openings are listed on our website.
- Golf season is winding down. The course is still open but check our website on inclimate weather days.
- IT has been busy integrating the new Clubhouse and Maintenance Facility into our network.

#### MARKETING AND COMMUNICATIONS UPDATE

Director Kelly Carbon gave the following update:

- ➤ The winter activity guide will now be delivered to homes by US mail due to the fact that some multi-home dwellings were not receiving their guides. A copy of the guide will also be available on our website as well as hard copies in our facilities.
- The Pavilion Fitness marketing campaign in November is centered around Good Health and Nutrition. Healthy recipes have been shared on the Pavilion Fitness November Eblast. You can receive these Eblasts by texting PAVFIT to 22828.
- ➤ In honor of Veterans Day and as a thank you to all that served, the customer service desks at Hattendorf and Pavilion are handing out a small gift to Veterans.

### **EXECUTIVE DIRECTOR UPDATE**

Executive Director Ben Curcio also thanked all men and women who have served our country and protected our freedoms. Director Curcio stated the Golf Course Clubhouse and Maintenance Facility is coming along nicely and is tentatively scheduled to open mid-December.

#### **COMMITTEE REPORTS**

Commissioner O'Malley stated at the last Committee of the Whole meeting there was a discussion on one of the items listed in the capital projects for 2020, which is lighting at Audubon ball fields. He asked that since this quarter of a million project has come to a stalemate is there something else that can be done with that money. Commissioner Carlson, who was not in attendance at the last meeting, stated that he does not see the upside for the size of the park. He added that he also would not like it if he lived there.

President Cooke shared that at tonight's Committee of the Whole meeting there was discussion on the 2020 Park Board meeting schedules. The consensus was to move the September 22, 2022 meeting to September 29, 2022 due to a conference that staff and Board members will be attending on the 22nd. Also discussed tonight was the proposed US vaccination mandate. This mandate is currently being held up by the federal judge.
