CAPITAL PROJECTS

Commissioner Cooke gave the following update:

- The OSLAD project at Hattendorf is done. The fence is down and the paths are open. The grand opening will be in the spring when the weather is nicer and the Adult Center reopens.
- ➤ The LED sign at Hattendorf has been installed.
- Dog Park discussion is still ongoing with a potential location of Woodland Meadows, which is owned by Cook County.

President O'Malley asked if the LED sign was 100% used by the Park District or if the Village can use it too. Executive Director Curcio stated it is controlled by the Park District but the Village can submit a request through Marketing if they would like something displayed on it. Director Carbon added that the sign is operational 24/7.

FINANCE COMMITTEE

Commissioner Walz gave the following update:

- ➤ Corporate Fund
 - Nearly \$450,000 in net property tax was collected in October
 - \$70,000 in replacement tax was collected in October
 - All expense categories are under budget except for insurance due to unemployment claims
- \succ Recreation Fund
 - \$173,328 in net property tax was collected in October
 - All expense categories are under budget

- Current Net year to date is \$109,000 compared to \$244,000 in 2019. A big reason for that is due to Covid19.
- ≻ Golf Fund
 - There were 2,403 rounds of golf played in October
 - All expense categories are at or under budget year to date except for contractual. This is due to higher credit card fees from bookings being done online due to Covid 19.
 - The Driving Range Net year to date is \$137,000 compared to a budget of \$94,000.
 - The 2020 Net year to date is \$436,000 compared to a 2019 Net year to date of \$211,000.

COMMITTEE OF THE WHOLE

President O'Malley shared that at tonight's meeting there was discussion on the gaming contract with Golf Rush Amusements that is up in February.

ATHLETIC COMMITTEE

Commissioner Biedke stated staff is ready to resume programs as soon as restrictions are lifted

GOLF COURSE COMMITTEE

Commissioner Walz stated he wants to set a date for the Golf Course Committee to meet. The course is still open and had 118 rounds played on December 9 and over 130 rounds played today. Total rounds for November were 1,935.

YOUTH COMMITTEE

Commissioner Biedke stated with everything shut down there have been no events or activities. The committee is meeting as a group in January to develop a plan for the upcoming year.

ADULT CENTER COMMITTEE

Commissioner Cooke had no report.

EXECUTIVE DIRECTOR UPDATE

Executive Director Curcio shared several accomplishments of the Elk Grove Park District in 2020. Some of the highlights include IT installing new cameras, and wireless network at the Fox Run temporary clubhouse trailer, the new Pavilion Aquatics Center play feature, the Easter Bunny parade, the launching of a virtual program guide, staff creation of forty virtual programs, drive-in movies nights, Summer Care camp, new playground equipment at Clark and Clearmont parks, and a new digital sign at Hattendorf.
