# **CAPITAL PROJECTS**

Commissioner O'Malley stated he and Commissioner Biedke met with Executive Director Curcio to review current and upcoming Capital Projects. These topics include Johnson Park pond sea wall repair, Audubon Outdoor Skate Park, Hampshire Park drainage, new roof for our maintenance facility at 140 Lively, new flooring in our Pavilion Fitness Center, new golf carts and the golf course maintenance facility and clubhouse design.

#### FINANCE COMMITTEE

Commissioner Souder gave the following report:

- ➤ In the Corporate Fund, all expense categories are under budget with the exception of benefits and the net revenue year to date is \$309,000 compared to a budgeted \$203,000.
- ➤ In the Recreation Fund, Program fees are \$338,000 year to date compared to a budget of \$312,000. Preschool and Dance are both significantly exceeding their budgeted year to date revenues. All expense categories are under budget for the month with the exception of a \$1,435 overage in program supplies. Net revenue year to date is \$214,000 compared to a budgeted loss of \$175,000. This could be due to timing of registration and taxes as well.
- ➤ In the Golf Fund, Banquet revenue is \$4,538 for the month compared to a budget of \$3,800. All expense categories are under budget. The Driving Range and Golf Course remained closed throughout the month of February.

#### **COMMITTEE OF THE WHOLE**

President Walz gave the following update:

➤ Topics discussed at the March 14, 2019 meeting included the potential termination of the Artist Association affiliate agreement, Queen of the Rosary parking lot and Fox Run maintenance facility design. At tonight's meeting discussion was on the Fox Run maintenance facility design and an update on Audubon Outdoor Skate Park.

## ATHLETIC COMMITTEE

Commissioner Souder stated that Director Miller, Jeff Collier, Jimmy Kavanaugh, Brian O'Malley and Director Sholes have done an outstanding job opening the lines of communication with the athletics groups. Football registration begins on April 6 at the Pavilion and an Athletics Committee Meeting is scheduled for April 10 at 5:30 p.m. at the Administration Building.

## **GOLF COURSE COMMITTEE**

Commissioner Souder stated the course is now open. The Bags League has completed their season, and the first event is the Miller Shootout on May 3.

## **PAYMENT OF BILLS**

Commissioner O'Malley moved to authorize Director Curcio to make payment of the bills in the amount of \$60,826.10 for March 13, 2019 and \$87,310.11 for March 21, 2019.
