APPROVAL OF CHANGE ORDERS #26, #40 #41 FROM WIGHT CONSTRUCTION

Commissioner Walz moved that the President find the Change Orders #26, #40 and #41 for a total of \$5,695.95 from Wight Construction is in the best interest of the Park District and otherwise authorized by law and that the President be directed to make such a determination in writing; and further authorized that upon being provided with said written determination from the President, the Executive Director be and hereby is authorized and directed to execute and deliver each such change order.

Commissioner Cooke seconded the motion.

Change order #26 is to replace hand towel dispensers with hand dryers in the washrooms at CAF. Change order #40 is to correct a code issue caught during the plumbing inspection. Change order #41 is to lay sod around the buildings. Commissioner O'Malley questioned why our staff is not laying the sod. Director Curcio replied the District purchased the sod but staff is too busy this time of year to lay it.

Upon original vote, Commissioner O'Malley and Commissioner Walz voted no to the approval of these change orders. Director Busby explained that not approving these change orders would delay the completion of the project. A re-vote was done and the change orders were approved.

LEISURE SERVICES UPDATE

Director Tammy Miller reported there were several fun "Bunny" events these past few weeks, and the feedback from those that participated was positive. Celebration of Cultures was held on Friday, April 7, and the Arbor Day Celebration will be occurring at 10:00 a.m. on Friday, April 28, at the Hattendorf Center. Staff has been working hard updating their 10-year capital plan and has been busy hiring for summer employment as well as planning for the openings of our summer facilities. We are still looking for more lifeguards. Camp registrations are on par compared to last year and so are Rainbow Falls pool passes. The early bird sales did well. Director Miller thanked Leigh Ferstein and Claire Naughton for the Wellness Team's new walking program. Five teams consisting of ten employees were formed with the goal of each participant get in a minimum of 10,000 steps per day.

PARKS AND PLANNING UPDATE

Director Ben Curcio reported that Grounds and Facility staff are working on getting the athletic fields and seasonal facilities ready for the season. There are thirty-four days until the opening of Pirates' Cove. The ship repairs are complete at Pirates' Cove and the path improvements are near completion. A damaged column at Rainbow Falls was replaced and painted. The interior slide refinishing has started and should be completed by the end of the month. Lifeguards will test the slides prior to opening season. All the Rainbow Falls pools have been sandblasted and are being prepped for painting. Commissioner Cooke asked with recent reports of people getting electrocuted in pools, has staff talked about a process. Director Curcio replied that newer pools are concrete grounded with rebar, which will prevent shock if a current, gets in a pool. He added that our pools are inspected regularly and everything is up to date and in code.

GOLF OPERATIONS UPDATE

Tom Klaas reported that rounds for March are the highest they have been in ten years, even with all the rain. Permanent tee times will begin on April 22. The Miller Shoot Out is the first event of the season taking place on May 5. Junior Golf registration is going on now for kids ages 5-14. The first class starts June 9. Revenue for Gaming through March has almost doubled compared to last year. The part-time Grounds Crew is back to work and is getting the course ready for the season. Parts for the parking lot lights haven been ordered and should be done in May.

BUSINESS SERVICES UPDATE

Director Rhonda Brewer reported the current agreement with Champion Energy expires in May. Requests for proposal went out for rates going forward. Champion submitted a rate slightly lower than our current rate, and was the lowest of all the companies that submitted proposals. Assuming the same usage over the next three years, we will be saving approximately \$18,000. The delivery component is billed by ComEd and is not part of this agreement. We have hired someone to fill the Finance Manager position. He will be starting on May 8. Some projects that I.T. has been working on include, ordering new copiers for the District, and setting up a wireless network at Community Athletic Fields.

EXECUTIVE DIRECTOR UPDATE

Director Tom Busby shared that Commissioner Tom Cooke won the election, even though the official count has not come from Cook County yet. At the CCC meeting last week, Director Tammy Miller was recognized for all the help she gives them. Director Busby also thanked her for being our liaison. Director Busby, along with Director Miller and Kelly Carbon, attended a breakfast with AARP Tax staff. This year they completed 425 tax returns with 70-80% being Elk Grove residents.

Commissioner O'Malley commented that with Commissioner Cooke's re-election, he is now the longest serving Commissioner serving the Elk Grove community. He added the town is lucky to have him. Commissioner Cooke responded that it is nice to serve when you have a good board to work with. He stated the dedication of the current board is amazing and he looks forward to six more years.

PAYMENT OF BILLS

Commissioner Walz moved to authorize Director Busby to make payment of the bills in the amount of \$105,465.01 for March 23, 2017, \$147,502.44 for March 30, 2017 and \$189,994.83 for April 6, 2017.
