

MINUTES OF THE REGULAR PUBLIC MEETING

APPROVAL OF MINUTES

President Walz questioned if there were any additions or corrections to the minutes of the June 14, 2018 Committee of the Whole Meeting and the June 14, 2018 Regular Meeting.

There being none, the minutes were approved by a unanimous voice vote.

COMMENTS FROM THE AUDIENCE

Resident Ray Prost addressed the Board to request additional information on the Hampshire Park drainage issue he brought up at the last meeting. Director Curcio responded that the District has hired WT Engineering to assess the situation. Commissioner O'Malley informed Mr. Prost that the Board has decided to have Director Curcio look into what the Park District can do but this is not just an Elk Grove Village issue, it may also involve Medinah and the Army Corp of Engineers and is not a simple fix. President Walz added that hiring an engineer shows that we are taking steps to see if this problem can be resolved.

CAPITAL PROJECTS

Commissioner O'Malley stated they plan to meet with Director Curcio in late July or August to discuss capital how the projects are going so far this year as well as discuss capital plans for 2019.

FINANCE COMMITTEE

Commissioner Cooke gave the following report.

- ➤ In the Corporate Fund:
 - Net revenue year-to-date in \$1,536,000 compared to a budget of \$69,000.
- ➤ In the Recreation Fund:
 - Fees and Admissions year-to-date is \$705,000, compared to a budget of \$686,000.
 - Program fees are \$844,000 year-to-date compared to a budget of \$856,000.
 - All expense categories are under budget.
 - Rainbow Falls had a good opening weekend with \$42,000 in Fees and Admissions.
 - Savings in all categories compared to budget year-to-date have a net revenue of \$518,000 compared to a budgeted loss of \$670,000, with the largest variance being capital projects that have not yet been completed.
- ➤ In the Golf Fund:
 - Fees and Admissions year-to-date are \$180,000 compared to a budget of \$216,000 due to the record rain in May.
 - Driving Range is above budget at \$25,000 compared to a budget of \$20,000
 - All expense categories are under budget for the year with the exception of Miscellaneous.

President Walz shared the following topics were discussed:

ATHLETIC COMMITTEE

Commissioner O'Malley stated the Athletic Committee has not met recently but at the Committee of the Whole meeting this evening, it was brought up that one of the associations was petitioning the residency rates. The majority of the Board agreed with Director Miller's recommendation not to allow these teams to be affiliated with us due to the low number of residents making up these teams. Commissioner O'Malley stressed our policy states our fields should be used primarily by Elk Grove Village residents and a team that is made up mainly of non-residents should not be allowed usage.

GOLF COURSE COMMITTEE

Commissioner Cooke reported the committee met on June 21, 2018 where they discussed the ideas from the architect for the potential renovations of the maintenance facility and clubhouse.

YOUTH COMMITTEE

Commissioner Biedke stated that he and Commissioner O'Malley attended the Village Board Meeting where four scholarships were awards; two from the Village and two from the Parks Foundation. He also shared that Mikerphone Brewering donated \$17,000 to the Youth Foundation. The next event is the Teen Summer Splash Party at Rainbow Falls on July 6 from 8:15-10:15 p.m. This is a free event for kids entering sixth grade through senior year in high school. In case of inclement weather, this event will be moved to the Pavilion Aquatics Center.

Commissioner Biedke stated he informed Trustee Franke and Kim Laper that Commissioner O'Malley is no longer on the Youth Committee, but now President Walz is.

ADULT CENTER COMMITTEE

Commissioner Cooke reported that a New Member Coffee will be held on July 10, from 10:00-11:00 a.m. In addition, a new chair exercise class will be held on Tuesdays at 11:00 a.m. starting in July.

PARKS FOUNDATION

The Foundation is selling raffle tickets to win one of two bicycles as well as other prizes. Tickets are one for \$10 or five for \$20. The winning tickets will be drawn at the Bike with the Mayor event on July 28.
