## LEISURE SERVICES UPDATE

Director Tiffany Greene gave the following update:

- Adult Center Memberships are up to 242. In February, the Sweetheart Luncheon had a record breaking 92 attendees. Seventeen participants attended the trip to Chorus Line at Drury Lane last month. Elk Grove High School leadership students came to the Center and helped members with general iphone questions. Ascension Health Medical provided health screenings for Heart Health month.
- Aquatics Group swim lessons reached 168 participants, preschool lessons were at 38 participants, private lessons maxed out at 32 participants, and parent/child lessons also maxed out with 30 participants. The Elk Grove Stingrays hosted the final home meet on February 11.
- ➤ Adult Athletics Winter Bags League has reached the midpoint and is on track to end April 5. Registration is now open for Adult Softball Leagues.
- Youth Athletics, Instruction The Illinois Park District Gymnastics Conference was hosted at the District on February 26. Hot Shots Sports has nine classes running with 88 participants. There are 23 participants enrolled in three tennis classes. Tumbling Times has 183 participants in 17 classes, Volleyball Prep Clinic has 33 total participants and Shotokan Karate has 84 participants across 5 classes.
- Youth Athletics Leagues Girls Softball registration closed on March 5 with 157 registrants. Spring Baseball registration is open with 146 players registered. Recreational Soccer registration opened on February 1 with 125 players currently enrolled. Football Winter Training ended February 19, and registration for the Spring 7 on 7 League is open with 50 participants currently enrolled. Youth Basketball's regular season is over, and Channel 6 will be broadcasting the championship games on March 17.
- > Audubon Skate Park There were 180 admissions in February.

- ➤ Cultural Arts, Art/Music/Theatre The Wizard of Oz performances will be March 24-26 at the Des Plaines Prairie Lakes Theatre. Tickets are on sale now.
- ➤ Customer Service The first day of Spring registration was March 1 with 204 registrations taken that day.
- ➤ Dance Winter Dance recitals took place on Sunday, February 5 at the Elk Grove High School theater. Over 800 people attended with an additional 300 watched via livestream.
- Early Childhood A record number of 72 families attended the 2023 Preschool Open House.
- ➤ In the month of February, Group Exercise had 1,652 participants, Personal Training had 122 sessions, Basketball had 503, Volleyball had 218, Pickleball had 122 and Racquetball/Walleyball had 70 participants.
- ➤ There were a total of 78 rentals in the month of February, compared to 34 in February 2022.
- > School Care Programs Kids Club had 1,490 registrations for the month of February and School Days Off had 20 registrants.
- > Special Events The Sweetheart Dance was held on February 10 with 100 guests in attendance.
- ➤ Youth/Teen Programs The Tween Pajama Spa Night that was held on February 10 sold out at 25 total participants.
- ➤ Upcoming events include Lucky Luncheon at the Sheila Ray Adult Center on March 15, an Adult Trip to The Dancing Horses Theatre in Delavan, Wisconsin on March 22, Easter Photos with the Bunny at the Carousel on March 31, Dancing with the Band on April 6, Doggy Egg Hunt on April 8 at the Museum, Parents Night Out at the Pavilion Aquatics Center on April 14, and a Tween Lock-In on April 14-15.
- ➤ In March there is a "No Enrollment Fee" special going on at the Fitness Center.

## PARKS AND PLANNING UPDATE

Director Kosbab gave the following update:

- > Parks and Planning staff are gearing up for the start of the spring season.
- > The Grounds team is disassembling the ice rinks and finishing up winter pruning.
- The Construction/Special Projects team have begun working at Osborn Park. Some residents asked if the new playground could be moved a bit further north so the playground is more visible. Director Kosbab thinks that will be possible.

#### **BUSINESS SERVICES UPDATE**

Director Brad Sholes gave the following update:

➤ There is no opening date yet for the golf course due to weather. In the meantime, the simulators are open. There is a One Club Madness Simulator Tournament taking place March 17-19.

Director Kelly Carbon shared the following information:

➤ The Sheila Ray Open House had over 50 attendees.
